Business Profile :

- **Airports:** GMR Group operates India's busiest airport, the Indira Gandhi International Airport (IGIA) in New Delhi.

It also developed and commissioned the Rajiv Gandhi International Airport (RGIA), a Greenfield International Airport at Hyderabad which is a gateway to South and Central India, and has taken over the operations and development of Mactan-Cebu International Airport (MCIA) along with its consortium partner Megawide Constructions.

GMR Group has been selected to develop, operate and manage the new international Kastelli airport, also known as Crete airport, in Heraklion, Greece, with a joint venture partner, Terna S.A., a Greek infrastructure company.

GMR Goa International Airport Limited (GGIAL), a subsidiary of GMR Airports Limited (GAL), is developing a Greenfield Airport at Mopa in North Goa.

In April 2020, GMR has also received LoA for the development and operations of green-field International airport at Bhogapuram in Andhra Pradesh.

- **Energy:** GMR Energy as a part of GMR Group has an operating capacity of over 4400 MW. It has a balanced fuel mix of coal, gas, LSHS as well as renewable sources of wind and solar energy. Apart from this, plants of over 2300 MW generation capacity are under various stages of development in India and Nepal.
- **Transportation:** GMR Group's Transportation business has 4 operational Highways covering a total length of 1450 lane Km. Two projects are on annuity model and two are toll based.
- **Urban Infrastructure:** The Urban Infrastructure sector was carved to manage the Group's foray into the businesses of Special Investment Region (SIR), property development and construction.

The Group is developing a 10,000 acre port based multi-product Special Investment Region at Kakinada, Andhra Pradesh and a 2,100 acre multi-product Special Investment Region (SIR) at Krishnagiri, Tamil Nadu.
